The fastening screws for sandwich panels are intended to be use for fastening of flat, lightly profiled or profiled sandwich panels to metal or timber construction. The intended use comprises fastening screws for sandwich panels and connection for indoor and outdoor applications. The fastening screws for sandwich panels which are made of stainless steel are intended to be used in external environment with high corrosion category. The intended use comprises connections with predominantly static loads (e.g. wind loads, dead loads). The component to be fastened is component I and the supporting structure is component II.
